1. Call to Order

Chair Dixon Doll called the special executive committee meeting to order at 4:10 p.m., a quorum being present. He announced that, due to the lack of a quorum of the full Commission, an action item on the agenda, "Election of Carmen Colet to the Asian Art Commission" would be carried over to the March 31 Commission meeting.

2. Approval of Minutes

Minutes from the September 22, 2009 Annual Meeting and the Special Full Commission meetings of October 20, 2009 and November 12, 2009 were approved as written.

3. Chair's Report

Dixon Doll welcomed special guests Joyce Hsu and Tim Kahn (and wife Anne Kahn), who were in attendance as Foundation Trustees-elect, and Joy Boatwright, and Maija Muncy Frisbee, leadership of the AAM Council. Dixon announced four recent committee chair appointments: Doug Tilden, Education and Programs (formerly chaired by Elaine Connell through 2000, and by Ellen Bauch through 2004); Michael Kim, Compensation Committee (formerly Jess Erickson); Richard Beleson, Acquisitions Committee (formerly Vickie Johnston); and Ken Docter, ad hoc Foundation Strategic Advisory Committee. Ad hoc Succession Committee co-chair Chuck Stockholm gave an update on the committee's work to date, noting the committee formed last October with a mandate to recommend a Commission and Foundation chair-candidate in advance of the completion of the current term of the office of chair at the September 28, 2010 annual meeting. Chuck noted the committee included co-chair Jane Tom as well as Bill Bowes, Sandy Calhoun, Vickie Johnston, Chong-Moon Lee, Doris Lee, Judy Wilbur, and Akiko Yamazaki. Chuck gave a summary of the committee's meetings to date (November, December and January), referenced the criteria sheet in the meeting packet, and again requested potential candidate names be submitted by January 31, noting the committee hoped to complete its mandate by April if not before. Senior Curator of Chinese Art Michael Knight gave a presentation on Shanghai scheduled to open February 25. Before calling on Jay Xu for the Director's Report, Dixon commended Jay and staff for the relationships they have renewed and further cultivated with the Mayor's Office.

4. Director's Report

Jay Xu presented highlights of business and events since the September annual meeting with particular emphasis on two major commitments to the Director's Campaign from (i) Fred Levin and Nancy Livingston, and (ii) Doug Tilden, each at \$500,000, noting total campaign funds raised to date had grown to \$4.5. He covered the close of *Emerald Cities*, events surrounding the imminent opening of *Shanghai*, future exhibitions into 2011, the launch of the museum's Contemporary Art Program and the initial phase of the museum's branding project. Jay introduced Doug Tilden, Education and Programs Committee Chair, who spoke about his high level view of the direction of the Education Committee, including acting as champions or advocates for the education department within the institution, and aligning the goals and objectives of the education community with the long term strategic plan of the museum. Director of Education Deb Clearwaters gave a brief update on recent and upcoming museum educational programs and initiatives.

5. Committee on Trustees Update

Foundation Committee on Trustees Co-Chair John Little and Commission Nominating Co-Chair Jane Tom announced candidates to be voted on later in the meeting. For the Foundation: Joyce Hsu, Tim Kahn, Barry Lam and Susy Wadsworth; for the Commission: Carmen Colet.

6. Development Report

Director of Development Amory Sharpe gave a brief update on FY 2010 fundraising for upcoming exhibitions, the Shanghai Gala and Arts of Pacific Asia. He called on Trustee Michael Kim who serves as liaison between the board and the AAM Council, the museum "next generation leaders," and Commissioner David Lei who reported on the relaunch of a comprehensive and reinforced program of planned giving—the Legacy Giving Program. David serves as chair of the Volunteer Advisory Committee of the Legacy program, which falls under the long-standing leadership of Joan Danforth's Richard B. Gump Society and is also supported by a professional arm, the Professional Advisory Committee, chaired by Trust Attorney Janet Dobrovolny.

7. Finance Report

Treasurer Ken Docter announced that the museum had secured a letter of credit for the bonds at the end of December and that the ad hoc Strategic Advisory Committee, formed to address bond-related matters, had met earlier in the afternoon and would meet on an ongoing basis to look at the long term. Ken reported on FY 09 financial status, FY 10 preliminary outlook and an investment update through December 31. On behalf of Audit Committee Chair Bill Kim, committee member Tom Woofter reported a clean audit and unqualified opinion with thanks to Audit Committee Chair Bill Kim and CFO/COO Mark McLoughlin and Controller Adrian Trujillo.

8. Consideration and Possible Action Items

a. Acknowledgement by Resolution of the Asian Art Museum of San Francisco Combined Financial Statements for the Years Ended June 30, 2009 and 2008 and Independent Auditors' Report

WHEREAS, In November 2002 the Foundation Audit Committee proposed that the Commission and Foundation acknowledge final audited financial statements by resolution annually; and

WHEREAS, The Foundation Audit Committee approved the draft 2009 and 2008 Financial Statements on November 12, 2009; and

WHEREAS, Copies of the final statements have been distributed to the Commission and Foundation; now, therefore, be it

RESOLVED, That the final Asian Art Museum of San Francisco Combined Financial Statements for the Years Ended June 30, 2009 and 2008 and Independent Auditor's Report are hereby acknowledged.
